The 2007 program organizers of the Southeast Case Research Association (SECRA) invite new and experienced case writers to submit original, unpublished cases, articles relating to the writing or application of case studies, case study embryos, or proposals for symposia to be presented at the 15<sup>th</sup> Annual SECRA Conference.

Submission Deadline: November 15, 2006

## **Purpose**

SECRA serves as a channel for the development and publication of case studies in all areas of business, education, social issues, technology, health care and other disciplines. SECRA is an interdisciplinary organization dedicated to the case method of instruction and the development of teaching and research cases. Cases with instructor's manual, papers, and proposals for symposia on topics dealing with the case method of learning and teaching will be considered. SECRA encourages newcomer and student submissions.

#### Southeast Case Research Journal

All cases and papers presented at the 15th Annual Conference will qualify for review and possible publication in the *Southeast Case Research Journal*. The SECRA journal is a refereed publication that encourages and promotes practitioner and educational case research for use in applied and academic settings. It is published biannually and listed in *Cabell's Directory of Publishing Opportunities*.

### **Important Dates**

- Full Cases, Case Abstracts, Papers and Panel submissions due: November 15, 2006
- Camera-ready abstracts or full cases, papers, and panels due: January 10, 2007
- To be included in the printed program, the registration fee must be paid by: *January 15, 2007*
- Registration fee cut-off date for reserving a hotel room at the conference rate: *January 15, 2007*

#### **Submission Information**

Submit cases to the appropriate track chair. Submit papers and symposia to the Program Chair. Field-researched cases are especially encouraged. During each SECRA conference, a special session is held offering newcomers to case writing and case embryo authors the chance to present case study ideas for critique by experienced writers. The session is targeted toward participants who wish to hone their skills before submitting a full case or article.

**SUBMISSION GUIDELINES:** The following guidelines are intended to facilitate the review and editing processes. Please make every attempt to follow the guidelines.

- 1. Submission Deadline: November 15, 2006
- 2. Cases or papers submitted must not have been presented or published elsewhere and/ or accepted for presentation or publication at another conference.
- 3. Cases should be typed, double-spaced, and no longer than 30 pages.
- 4. Each case must have an accompanying instructor's manual (teaching notes), a title page, and a one-page abstract.
- 5. The title page should include name, affiliation, address, phone, and e-mail address for all authors. Indicate the contact author. Identify student submissions (student must be the sole author for award consideration).
- 6. The main body of the case should have a title only and no references to the author or the author's affiliation.
- 7. The instructor's manual should include a title page with authors' names and affiliations as noted above in item number 5. The main body of the instructor's manual should have the title of the case only and no references to the author or the author's affiliation.
- 8. Submit the case and materials as an e-mail attachment to the appropriate Track Chair listed below <u>and</u> to the Program Chair (Mick Fekula, University of South Carolina Aiken, (803) 641-3203, <u>mickf@usca.edu</u>).

#### **Conference Fees**
